The club challenge is to make 12 – beads and coves sticks WITH YOUR SKEW ONLY.....Pick a 2x4 with minimal knots, cut it up into 1' lengths then cut it in half, round it using peeling or plaining cuts, then mark out your beads and have fun. This is definitely a skill builder. The goal is to have 12 completed by the September meeting. That is 12 weeks, 1 per week. I think it will be interesting to see the change between week #1 and week #12.

Who's up to the challenge? We will see in September.

We could also send John snippets, and he'll put them all together to make the demo for the meeting. Videos do not have to be narrated. Linda has issued a challenge to John to post items. John will post some items on CCW website.

Discussion ensued on drying green wood. Tom said that David Ellsworth does a great demo on turning a green bowl. That would be another good demo.



THE BUTTONBALL

While out on an errand, I saw this huge Sycamore tree. On the way back, I stopped to get a good look at it. To my surprise, it is believed to be the largest American Sycamore on the East Coast. It is massive. It's located on HWY 116 in Sunderland Ma. near Deerfield and called the Buttonball Tree. It's girth measures 25' 8" at 4.5', 113' tall and 140' wide. There is a plaque commemorating the 200th anniversary of the signing of the Constitution and the tree's age; arborists estimate it is 350-400 years old. I was in awe. It is hard to show on a photo, but for perspective this would almost shade an entire little league baseball field.

So, if you're up in the area, take a few minutes to stop and take a gander, and reflect at one of the few survivors from centuries ago.
